**Item Summary**

The attached document reflects the official results of the Special Election of the City of Prescott held on November 8, 2011.

**Background**

The City of Prescott held its Vote-By-Mail Special Election on November 8, 2011. The ballot included the two-year (short) term Council seat and eight Charter amendments. Out of the 24,818 registered voters in the City, 9,702 ballots were cast in this election, providing a 39% voter turnout. The final results are as follows:
