**FINGERPRINT APPLICATION FORM**

**In accordance with 49 CFR 1542.209:**

I have been advised that City of Prescott Airport (PRC) must collect, control and process one set of legible classifiable fingerprints under the direct supervision of PRC's Security Office.

I hereby certify the information I have provided on this application is true, complete, and correct to the best of my knowledge and belief and is provided in good faith. I understand that a knowing and willful false statement on this application can be punished by fine or imprisonment or both (Section 1001 of Title 10 United States Code).

I understand that if my fingerprints cannot be classifiable, I will be fingerprinted a second time.

I have been advised that if a disqualifying crime has been disclosed, I will have 30 days to notify the Airport Manager in writing of my intention to correct information that is incorrect. If notification to correct record is not made within 30 days, a final decision to deny access will be made.

I have been advised that I will be notified by the PRC ASC of a final decision to grant or deny unescorted access authority.

I have been advised that the PRC Airport Security Coordinator (ASC) is my point of contact if I have questions about the results of the criminal history records check.

I have been advised that a copy of the criminal record received from the FBI will be provided to me, if requested in writing.

I am under a continuing obligation to disclose to PRC within 24 hours if I am convicted of any disqualifying criminal offense that occurs while I have unescorted access authority.

I hereby certify that I have not been convicted, or found guilty by reason of insanity, of any of the listed disqualifying crimes in any jurisdiction during the ten years before the date of my application for unescorted access authority.

**I certify that I have not been convicted of any disqualifying criminal offense listed below:**

- 1) Forgery of certificates, false marking of aircraft, and other aircraft registration violations, 49 U.S.C. 46306.
- 2) Interference with air navigation, 49 U.S.C. 46308.
- 3) Improper transportation of a hazardous material, 49 U.S.C. 46312.
- 4) Aircraft piracy, 49 U.S.C. 46502.
- 5) Interference with flight crewmembers or flight attendants, 49 U.S.C. 46504.
- 6) Commission of certain crimes aboard aircraft in flight, 49 U.S.C. 46506.
- 7) Carrying a weapon or explosive aboard aircraft, 49 U.S.C. 46505.

- 23) Distribution of, or intent to distribute, a controlled substance.

  - a) Willful destruction of property;
