In return for the City’s release of record drawings, the user agrees to waive any claim against the City , its employees, officials, volunteers, agents and representatives and, to the fullest extent permitted by law, the user shall assume the defense of, indemnify, and hold the City harmless from any claim or liability for injury or loss allegedly arising from this authorized use or any unauthorized re-use of the documents, excepting only such liability as determined by a court or forum of competent jurisdiction to arise out of sole negligence or willful misconduct of the City.

User further agrees to compensate the City for any time spent or expenses incurred by the City of Prescott in defense of any such claim, in accordance with the City’s prevailing fee schedule and expense reimbursement policy, and/or the existing fees needed to defend any claims and prevailing rates in the community charged for such defense said expenses include, but are not limited to, court costs and reasonable attorneys’ fees.
