

NOTICE INVITING BIDS

PROJECT: FY 2011 AR-ACFC Overlay

DESCRIPTION: This project consists of approximately 36,000 square yards of ACFC asphalt rubber overlay and tack coat on sections of Demerse Avenue, Rosser Street, and Gail Gardner Way, including, adjustment of manholes, valves, handholes, and cleanouts, striping, and pavement markings.

All bids will be opened and read aloud at 2:00 P.M. on Thursday, May 20, 2010 in the City Hall Council Chambers, 201 South Cortez Street, Prescott, Arizona.

Any bid received at or after 2:00 P.M. on the above stated date will be returned unopened. The City of Prescott reserves the right to accept or reject any or all bids, and/or some or all of the alternates bid, and waive any informality deemed in the best interest of the City and to reject the bids of any persons who have been delinquent or unfaithful to any contract with the City of Prescott.
