

NOTICE INVITING BIDS

PROJECT: FY 2012 Pavement Rehabilitation Project

DESCRIPTION:

The project generally consists of milling existing asphalt pavement and replacing with new asphalt pavement on selected streets, and the construction of ACFC-AR pavement overlay on streets as shown on the plans. The work includes crack sealing on an as needed basis, full depth pavement repairs where needed, the installation of crack reducing pavement fabric, the adjustment of utility covers to finish grade, the installation of vehicle detector loops, and the restoration of disturbed traffic striping. The work also includes the provision of public relations services. The selected streets are Willow Creek Rd from Whipple St to Green Ln, Iron Springs Rd from Gail Gardner Way to Whipple St, Goodwin St from Montezuma St to S. Mt. Vernon Ave, and Granite St from Gurley St to Willis St.

Sealed bids will be received at Public Works, addressed to the attention of the Public Works Director, City of Prescott, 433 N Virginia Street, Prescott, AZ, 86301, before 2:00 pm on Thursday, June 23, 2011 for furnishing all plant, materials, and labor and performing work for construction of the FY 2012 Pavement Rehabilitation Project.

The outside of the bid envelope shall indicate the name and address of the bidder, shall be addressed to the Public Works Director, City of Prescott, 433 N Virginia Street, Prescott, AZ 86301, and shall be marked: "Bid: FY 2012 Pavement Rehabilitation Project." All bids will be opened and read aloud at 2:00 pm on Thursday, June 23, 2011 in the Public Works Conference Room, 433 N Virginia Street, Prescott, Arizona.

Any bid received at or after 2:00 pm on the above stated date will be returned unopened. The City of Prescott reserves the right to accept or reject any or all bids, and/or some or all of the alternates bid, and waive any informality deemed in the best interest of the City and to reject the bids of any persons who have been delinquent or unfaithful to any contract with the City of Prescott.
