

NOTICE INVITING BIDS

PROJECT: Rosser St/Adult Center Drainage Channel

DESCRIPTION: This project includes the construction of an outflow channel for the proposed Rosser Street culvert crossing located just east of the Adult Center. The channel will daylight onto the existing undeveloped portion of parcel 105-04-026, which is City property. This project also includes 8-inch Ductile Iron Pipe water main relocation. Due to the presence of Malapai Rock this project is considered to possibly have hard dig conditions.

All bids will be opened and read aloud at 2:00 pm on Thursday, April 14, 2011 in the Public Works Conference Room, 433 N Virginia Street, Prescott, Arizona.

Any bid received at or after 2:00 pm on the above stated date will be returned unopened. The City of Prescott reserves the right to accept or reject any or all bids, and/or some or all of the alternates bid, and waive any informality deemed in the best interest of the City and to reject the bids of any persons who have been delinquent or unfaithful to any contract with the City of Prescott.
