<b>Location:</b>	<ul style="list-style-type: none"> <li>• <b>Zone 39 Water Main and Pump Station</b></li> <li>- New Pump Station at the corner of Pioneer Drive and S. Hassayampa</li> <li>- White Spar Road from Granite St. to Copper Basin Road</li> <li>- Aubrey St. from S. Pleasant to new Pump Station at Pioneer Drive</li> <li>- S. Hassayampa from new Pump Station to Park Avenue</li> </ul>
<b>Description of work performed and traffic impact:</b>	<p><b><u>WATER LINE INSTALLATION</u></b>  <b>Monday, June 7<sup>th</sup> through Thursday, June 10<sup>th</sup></b>  <b>7 a.m. to 5:30 p.m.</b>          With the final overlay paving finished, the Zone 39 Construction Phase I is significantly complete. Minor grading and miscellaneous work associated with the project will be performed over the next two weeks, but no major traffic impacts are anticipated. Area residents and motorists should remain alert for construction traffic during this time.          Lanes may be restricted where crews are working.</p> <p><b><u>PIONEER PUMP STATION</u></b>  <b>Monday, June 7<sup>th</sup> through Thursday, June 10<sup>th</sup></b>  <b>7 a.m. to 5:30 p.m.</b>          Following the successful completion of the seven-day test of the new pump station and the fire flow tests, the new Pioneer Pump Station is now online. Contractor will perform miscellaneous work inside and outside of the Pump Station next week.</p> <p>Motorists should remain alert for construction workers and equipment at the intersection of Pioneer Drive and Hassayampa Drive and should follow well-marked detours. Please drive slowly and safely along detour routes.</p> <p><b>The City of Prescott and A. Miner Contracting are proud to bring infrastructure improvement such as this to the Prescott community. Your support has been appreciated as our crews work to upgrade the Zone 39 utilities.</b></p>

<b>Description of work performed and traffic impact:</b>	<p><b><u>Country Club, Street and Utility Improvements</u></b></p> <p><b>Monday, June 7<sup>th</sup> through Thursday, June 10<sup>th</sup> from 7 a.m. to 5:30 p.m.</b></p> <p>Paving completed along Country Club Drive from Vista Drive to Verde Lane, crews may be working throughout the project area performing miscellaneous work required to finish Phase II. While work will largely occur off the roadway, this work may require traffic control where needed.</p> <p><b><u>Zone 39 Phase III</u></b></p> <p>With the demolition and removal of the existing water reservoirs atop Indian Hill complete, construction of the new 1.33 MG reservoir has begun; crews completed installing the ringwall and the foundation for the retaining walls for the new reservoir. They also continue the installation of a 16-inch water line and storm drain pipe throughout the week. The water line will connect the new reservoir to the new water mains along Country Club Drive. Trucks hauling materials to and from the site will be traveling along Country Club Drive from Park Avenue to Indian Hill. Please be aware of the following:</p> <p>While work will largely occur off the roadway, occasional, short-term traffic impacts may be experienced at the Indian Hill access road and Country Club intersection. Residents should use caution to move through the project area and be aware of construction traffic.</p> <p><b><u>PEDESTRIAN ACCESS RESTRICTIONS</u></b></p> <p>Due to safety concerns, pedestrian access through the work zone is prohibited for the duration of Phase III. This means that the access road to the summit of Indian Hill is closed to recreational use.</p>
