

RESOLUTION NO. 4326-1535

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF PRESCOTT, YAVAPAI COUNTY, ARIZONA, RESCINDING RESOLUTION NUMBER 3846-0909 AND ADOPTING A NEW RESOLUTION ESTABLISHING AND ADOPTING A REVISED FEE SCHEDULE PERTAINING TO FIRE DEPARTMENT PERMITS, INSPECTION FEES, LICENSING AND CERTIFICATION FEES, PLAN AND PLAT REVIEW FEES AND MISCELLANEOUS FIRE SERVICES FEES.

RECITALS:

WHEREAS, the City Council has previously established fees pertaining to fire inspection, permitting, licensing and other related fees pursuant to Resolution No. 3846-0909; and

WHEREAS, the City Council wishes to now rescind Resolution No. 3846-0909 and establish a new resolution setting forth current fees for such services commencing upon the effective date of this Resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PRESCOTT AS FOLLOWS:


SECTION 1. THAT Resolution Number 3846-0909 is hereby rescinded in its entirety.

SECTION 3. THAT the Mayor and staff are hereby authorized to take such steps as may be necessary to effectuate this Resolution No. 4326-1535.


SECTION 4. THAT this Resolution shall take effect and be in force on the 16th day of June 2016.
