THIS NEW LEASE NUMBER SHOULD BE REFERENCED IN ANY CORRESPONDENCE WITH THE GOVERNMENT AND IS REQUIRED IN ORDER FOR THE GOVERNMENT TO PROCESS FUTURE LEASE PAYMENTS.

CURRENT ANNUAL RENT IS \$40,454.80 PAID MONTHLY IN THE RATE OF \$3,371.23 IN ARREARS.
