A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF PRESCOTT, YAVAPAI COUNTY, ARIZONA, TO CONTINUE IN FORCE THE CITY OF PRESCOTT CALENDAR YEAR 2018 WATER MANAGEMENT POLICY, AND AUTHORIZING THE MAYOR AND STAFF TO TAKE ANY AND ALL STEPS NECESSARY TO ACCOMPLISH THE ABOVE.

RECITALS:

WHEREAS, the City of Prescott is located within the Prescott Active Management Area; and

WHEREAS, the City of Prescott recognizes water as a finite resource that must be carefully managed; and

WHEREAS, the City finds it appropriate to review, revise and update its Water Management Policy; and

WHEREAS, the City's review of its Water Management Policy will not be completed before calendar year 2018 has ended.

ENACTMENTS:

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PRESCOTT AS FOLLOWS:

Section 1 THAT, the City of Prescott hereby extends in force the City of Prescott Calendar Year 2018 Water Management Policy until July 1, 2019, subject to the following alterations:

- A. Any applications for water to serve four or fewer residential units may be approved by the City Manager.
- B. Alternative Water Allocation Policy 11 is stricken.
- C. The 2018 Alternative Water Budget Table is stricken.

Section 2 THAT, the City of Prescott allots 350 acre feet of water for allocation to any development of any type during this period, after an application for water service is processed in accordance with the policy. That volume of 350 acre feet shall consist of the 300 acre feet remaining in the City's General Pool and 50 acre feet from the City's reservation for vacant residential lots.

Section 3 THAT, the Mayor and Staff are hereby authorized to execute the attached policy and to take any and all steps deemed necessary to accomplish the above.
