 - 1. Cutter currently deals with General Aviation Pilots.
 - 2. Cutter does give a discount to based tenants on fuel. Cutter will investigate the current fuel prices in the area and work with the community and organizations to have price adjustments based on these prices and for full services vs self-service.
 - ii. Will emergency and routine maintenance be offered with Cutter? (Elliott Schulman)
 - 1. Cutter wants to work with the people and will continue to do the same as Legend for Maintenance.
 - iii. Will maintenance be in-house for engine services? (Mike Liveridge)
 - 1. Cutter will work with a vendor to help with engines.
 - iv. Will Cutter be keeping the crew that Legend has now? (Jeff Wiesel)
 - 1. Yes, all employees will stay on.
 - v. Will the pass-through flowage fee be lower than it currently is? (Loren Harmen)
 - 1. This fee is set by the city and is currently at 15 cents.
 - vi. Daryl Austermiller will get Peter from Cutter the fuel survey.
 - vii. Any possibility of other fuels, UL? (Lance Leighnor)

1. Unless there is a good number of planes using UL, it would not be feasible. If it becomes mandated for low lead or unleaded then Cutter will need to figure out a way to inject the lead on the planes that still will need it.
